**Subject: Election – National Chairperson; Term July 1, 2018 to June 30, 2021**

Effective midnight June 30, 2018, the current term for the National Chairperson will be completed necessitating that we now begin the process of Calling for Nominations for this position.

The National Chairperson's term of office is three years and is open to all dues-paying regular members of the Canadian Federal Pilots Association. Relocation costs for an incoming Chairperson are paid in accordance with the Treasury Board's directives on Relocation, however, the National Chairperson's contract guarantees that any expenses incurred in relocating a new Chairperson will be reimbursed to the Association on a pro-rata basis should he/she have to leave prior to the end of term.

The National Chairperson will be paid at the top of the CAI-05 pay scale including EDA, or such higher salary as related to their current incumbent position. The Employer's share of the superannuation differential between the Chairperson's substantive rank and his/her Chairperson's salary shall be set aside by the Association as savings to be presented to the incumbent at the end of his/her term of office.

The National Chairperson is on loan from the Government/NAV CANADA and is on leave without pay. A clause in the National Chairperson's contract allows that he/she present to the Association's Executive Board a proposal for maintaining flying currency at each fall Executive Meeting. In addition to the duties outlined in the Association's Constitution, the National Chairperson carries responsibilities as a director on the Board of the Association's Labour Sponsored Investment Funds.

May 2, 2018	Count ballots and declare successful candidate
